

Application and Agreement

The *Strottner Gives Back* program was developed to support non-profit organizations that are working to make their part of the world a better place! Deadline for the application is December 1 for the First Quarter of each year, March 1 for the Second Quarter, May 1 for the Third Quarter and September 1 for the Fourth Quarter.

Please email the completed application, the IRS determination letter for status (or equivalent), and any additional materials to support@strottner.com to be eligible and apply for the free website by deadline above. If you are not chosen for the quarter you are applying for, or you submit past deadline, we will keep your application on file and consider your organization as a future recipient.
